TERMS:

THE DIRECTORS RESERVE THE RIGHT, AT THEIR SOLE DISCRETION, TO WITHDRAW ANY CAMPER WHOSE INFLUENCE AND ACTIONS ARE DEEMED UNSATISFACTORY TO THE BEST INTERESTS OF THE CAMP OR WHO WILL NOT LIVE WITHIN THE RULES AND POLICIES OF THE CAMP. IF THIS OCCURS, NO REDUCTION OR RETURN OF FEE, OR ANY PART THEREOF, WILL BE MADE. DUE TO FIXED COSTS AND EXPENDITURES BASED ON DEFINITE ENROLLMENTS AND DATES, NO REFUNDS OR REDUCTIONS CAN BE MADE FOR ENTERING OR WITHDRAWING EARLY. IN THE EVENT I CANNOT BE REACHED IN AN EMERGENCY WHEN MY CHILD IS UNDER BIRCH HILL SUPERVISION, I HEREBY GIVE PERMISSION TO THE PHYSICIAN SELECTED BY THE CAMP DIRECTOR TO HOSPITALIZE, SECURE PROPER TREATMENT FOR, AND TO ORDER INJECTIONS, ANESTHESIA, OR SURGERY FOR MY CHILD. MY CHILD HAS PERMISSION TO PARTICIPATE IN ALL CAMP PROGRAMS, CAMP TRIPS, AND SPECIAL OUTINGS PLANNED AND SUPERVISED BY BIRCH HILL. I GIVE BIRCH HILL SUMMER CAMP PERMISSION TO REPRODUCE AND PUBLISH ANY PHOTOGRAPH, VIDEO OR LIKENESS OF MY CHILD FOR ADVERTISING, COMMERCIAL OR ANY OTHER PURPOSE THAT IS CAMP-RELATED. BIRCH HILL IS NOT RESPONSIBLE FOR LOST OR STOLEN ITEMS WHILE AT CAMP. IT IS RECOMMENDED THAT CAMPERS DO NOT BRING VALUABLE OR ELECTRONIC DEVICES TO CAMP. IT IS AGREED THAT ANY DISPUTE OR CAUSE OF ACTION ARISING BETWEEN THE PARTIES, WHETHER OUT OF THIS AGREEMENT OR OTHERWISE, CAN ONLY BE BROUGHT IN A COURT OF COMPETENT JURISDICTION LOCATED IN NEW HAMPSHIRE, AND SHALL BE CONSTRUED IN ACCORDANCE WITH THE LAWS OF NEW HAMPSHIRE. I UNDERSTAND THAT PART OF THE CAMPING EXPERIENCE INVOLVES ACTIVITIES, GROUP LIVING ARRANGEMENTS AND INTERACTIONS THAT MAY BE NEW TO MY CHILD. THESE THINGS COME WITH CERTAIN RISKS AND UNCERTAINTIES BEYOND WHAT MY CHILD MAY BE USED TO DEALING WITH AT HOME. I AM AWARE OF THESE RISKS, AND I AM ASSUMING THEM ON BEHALF OF MY CHILD. I REALIZE THAT NO ENVIRONMENT IS RISK-FREE AND SO I HAVE INSTRUCTED MY CHILD ON THE IMPORTANCE OF ABIDING BY THE RULES.
